Παρασκευαΐδης, Μ., Τὰ χαρακτηριστικὰ τῆς προϊστορικῆς τέχνης τῆς Ἑλλάδος, Καθημερινή, 24 January 1965.

A new look at the chronology of Greece from the Neolithic period onward, lately revised by A. Sakellariou and E. Papathanasopoulos and presented in the new Short Guide to the National Archaeological Museum at Athens. An analysis of the exhibits has helped in more closely determining the date of the arrival of the first Greeks. A similar analysis has shed more light on the origins of Minyan pottery, the Middle Helladic "village civilization" of Greece, the interaction between Minoan Crete and the mainland, and the art of the Cycladic civilization.
